HELP CFSD STUDENTS AND REDUCE YOUR
STATE TAX BILL

Use your 2025 Arizona school tax credit to help a child get more out of school.

Arizona law (ARS 43-1089.01) allows taxpayers to receive a tax credit of up to \$200 (single filer) or \$400 (joint filers) if they contribute to extracurricular fee-based programs in public schools. A **tax credit** is a full refund of what you owe in state taxes, dollar-for-dollar.

Here's how it works:

Just send a donation to the Catalina Foothills School District, earmarked for support of one of our many qualifying fee-based extracurricular activities. (See below.) We will send you a receipt for your records. Then, when you fill out your 2025 Arizona state taxes, you can subtract your donation – up to \$400 – from what you owe in taxes.

Tax credit limit:

- \$400 for married couples filing jointly
 - \$200 for single taxpayers
 - \$200 each for married couples filing separately
